## **Addressing Elder Homelessness Through Housing and Supportive** Services: A Current Assessment


Hearth stands as a steadfast ally to elders facing the harsh realities of homelessness. Central to our mission is Hearth Housing-a critical initiative providing not just shelter, but a lifeline of stability, dignity, and hope for vulnerable elders in need.

Currently, Hearth Housing comprises 228 units of supportive housing and assisted living, serving as a crucial resource for elders grappling with housing insecurity. Yet, despite our efforts, the demand for affordable housing continues to surge, outstripping the available supply. This pressing issue is underscored by a recent 2023 report by Channel 7, which revealed a

sobering statistic: in Boston alone, 1,700 adults aged 55 and above experienced homelessness, with 443 of them surpassing the age of 65. This distressing trend emphasizes the urgent need to expand our housing initiatives to accommodate the escalating population of homeless elders.

As the homeless demographic ages, so do our residents in supportive housing and assisted living. This demographic shift necessitates a nuanced approach to ensure our services meet the evolving needs of our aging population. To this end, we are actively engaging with medical professionals in gerontology to glean

insights and guidance on how best to support our residents as they age in place.

Innovative initiatives led by our board members further underscore our commitment to proactive care. For instance, plans are underway to introduce physical therapy and occupational therapy interns into Hearth sites. These interns will not only deliver valuable services such as chair yoga sessions but also conduct comprehensive assessments of our residents' apartments to mitigate fall risks and enhance safety measures. By addressing these concerns head-on, we aim to bolster the quality of life for our residents and empower them to maintain independence for as long as possible.

While housing serves as the cornerstone of our efforts, it is but the first step towards stability and well-being. To this end, Hearth offers a comprehensive suite of supportive services tailored to the diverse needs of our residents. From case management and healthcare access to life skills training and social engagement opportunities, our holistic approach aims to foster independence and self-sufficiency among our residents.

Looking ahead, our focus remains resolute on expanding our housing initiatives, fortifying our supportive services, and advocating for policies that prioritize the needs of homeless elders. With each new unit of housing, each life transformed, we edge closer to our vision of a community where every elder has a place to call home and the support they need to thrive.

## A Lifeline for Homeless Elders in Greater Boston

Our Outreach Department plays a pivotal role in extending a helping hand to those in need, offering a lifeline of support through housing search, stabilization services, and homelessness prevention initiatives.

**Housing Search:** The quest for stable housing is fraught with challenges, particularly in a city where the cost of living continues to rise, and affordable housing remains scarce. Yet, despite these obstacles, our dedicated outreach team tirelessly navigates the housing landscape, working to secure housing for both sheltered and unsheltered homeless elders. Their efforts are fueled by a deep commitment to ensuring that every elder has a place to call home—a sanctuary of stability and security in an uncertain world.

**Stabilization Services:** Securing housing is just the first step on the journey to stability. Once an individual is housed, our outreach department springs into action, assigning dedicated case managers to provide personalized support as they transition into housing. ## Mobilizing Partnerships to Combat Homelessness


